Stewards will have the power to remove from the Carnival ground any exhibitor or articles for sale that are deemed inappropriate. The committee, its officials & stewards shall not be held responsible for any accident, (fatal or otherwise), damage or loss, (however caused), that may occur to persons, property or goods exhibited on the Carnival ground. Exhibitors are required to remove all litter at the close of the Carnival. exhibitor may only sell items that are detailed on this application form.

If for any reason an exhibitor/Stall wishes to withdraw or cancel booking all fees will be forfeited. However, if the Carnival is cancelled all monies will be repaid.

## **Unsuitable Traders;**

The stewards & officials have the power to remove from the Carnival any exhibitor whose articles are not in accordance with the description given on the application form Or any vendor of shoddy articles, or who use unsuitable methods of trading, or any itinerant vendor who may have gained access to the Carnival. The definitions of what constitutes shoddy or unsuitable shall rest entirely with the stewards & Carnival officials.

## **Temporary structures (marquee)**

All temporary structures (tents, gazebos,) are properly secured with all Anchor points by staked to the ground or Sand bags. All (inflatable tarpaulins) are properly secured at all Anchor points by staked to the ground

## **Litter;**

Exhibitors are required to remove all their litter before they leave the Carnival ground. There will be a skip on site.
